S.No.	Decision/Remarks by Home Department – Legal Position under Arms Act/Arms Rules
1	<p>It is recommended that the Photograph of the Licencee be printed on the Arms Licence. However it is observed that the photographs taken by web cams are not clear because of the low pixel quality of the web cams currently used in the Suvidha Centres for various purposes. Alternatively, the licencees may supply latest coloured photographs (with light background) which may be affixed/pasted on licences. If However, the printed photographs are decided, the cameras used must be of high resolutions in Suvidha Centres.</p> <p>The applicable rule is 52(1) of the Arms Rules, 1962. A licence in Form II, Form III, Form III-A, Form IV, Form V or Form VI, if granted for more than a year, to a person other than a bonafide tourist as defined in section 10(1)(b) of the Act, <b>shall be in a book form and shall contain the latest photograph of the licencee.</b></p> <p>It is a wrong interpretation that the applicant photo is only mandatory for issuance of new arms licence. Attention is drawn to section 15(3) of the Arms Act, 1962 which stipulates that the provisions of sections 13 and 14 shall apply to the renewal of, a licence as they apply to the grant thereof. Accordingly, every application for renewal has to be treated as a fresh application of arms licence and all the rules laid down for fresh licence are to be applied to renewal applications.</p>
2	<p>There is no bar on number of times of renewal of arms licence by a licencee under the Arms Act, 1962 and the Arms Rules, 1962.</p>
3	<p>The applicant licencee is to apply well within time for renewal of arms licence. However, relaxation is provided in Form III, (Point II), wherein it is provided that the reduced fees for renewal will ordinarily be available only if application for renewal is made with in one month after the date of expiry of the licence.</p> <p>Otherwise, any delay in applying for renewal is a violation of the conditions of the licence. Discretionary Powers are available to the Licensing Authority under Rule 54(4) of the Arms Rules, 1962, where in it may consider an application for renewal in case of delay on case to case basis.</p>
4	<p>Maximum 3 three weapons can be endorsed as provided in Section 3 of the Arms Act, 1962. Technically there is no bar if these three weapons are all revolvers/pistols/rifles/guns. However as per the practice, normally one gun, one rifle and one revolver or pistol of permissible NPB Bores are allowed to be entered on the licence.</p>
5	<p>As stipulated by Rule 52(1) a licence granted in Form III has to be in a book form. The size is not relevant. The printout of the output certificate may be adjusted as per the licence book. The suggestion of giving output certificate on single page is not legally allowed. It has to be pasted on the licence book.</p>
6	<p>The new licence book to be issued must mention that it has been issued in lieu of the old licence bearing no. _____. The series of the new licence number generated in the new software must have DUP series (e.g. the new licence no. will read CP/ASR/DUP/CL/1212/9, where in CP means Commissioner of Police, ASR means Amritsar, DUP means the licence number has been regenerated, CL means Civil Lines Police Station, 1212 means Dec, 2012 and 9 means the running serial number of the Civil Lines Police Station in the year 2012.</p>
